2. Chairman Jamie Ponville requested approval of the 2025 carryover projects to 2026 as presented. The Secretary-Treasurer presented the list of carry over projects to the jury for approval. Police Jurors Ron Alcorn and Michael Dias stated that projects #93135, #93285, #93147 and #93193 should be removed from the listing as the projects have been completed.
3. Committee member Myron Matherne, offered a motion, seconded by Mr. Charles Breaux, "THAT, the committee approve the 2025 carryover projects to 2026 as presented with the exclusion of projects #93135, #93285, #93147 and #93193." The motion was unanimously adopted.
4. Chairman Jamie Ponville requested approval of Substantial Completion of the Himalaya Canal Clearing project. Mr. Joseph Savoie stated that the project is complete and photos will be emailed to all jurors.
5. Committee member Chris Carter, offered a motion, seconded by Mr. Charles Breaux, "THAT, the committee approval substantial completion of the Himalaya Canal Clearing project." This motion was unanimously adopted.
6. Chairman Jamie Ponville requested approval for CJ Savoie Engineering to re-advertise the Marais Area Drainage Improvements project and consider a scope modification in the amount of \$13,457.50 for additional engineering fees. Chairman Ponville asked Mr. Savoie to elaborate on the scope modifications that were done. Mr. Savoie stated that all the natural gas engines were converted to diesel engines, cross sections were removed from all the plans, the deck was lowered by 2 ft., all resulting in renumbering of all the plan sheets.
7. A discussion was then held relative to identifying the funding source. The Parish Manager recommended that the funds be re-allocated from project #93133.
8. Committee member Charles Breaux, offered a motion, seconded by Mr. Chris Carter, "THAT, the committee approval and authorize CJ Savoie Engineering to re-advertise the Marais Area Drainage Improvements project and approve an additional \$13,457.50 for additional engineering fees associated with the scope modification to be funded from project #93133." This motion was unanimously adopted.

1. Committee members recorded as present were: Mr. Leroy Blanchard, Chairman; Mr. Jeff Naquin, Mr. Chris Carter, Mr. Ron Alcorn, Mr. Jamie Ponville
Other Police Jurors recorded as present were: Mr. Michael Dias, Mr. Charles Breaux, Mr. Myron Matherne, Mr. Ira Patureau
2. Chairman Leroy Blanchard requested approval to pay the List of Bills submitted through January 9, 2026.
3. Committee member Jeff Naquin, offered a motion, seconded by Mr. Chris Carter, "THAT, the committee approve to pay the List of Bills submitted through January 9, 2026." This motion was unanimously adopted.
4. Chairman Leroy Blanchard requested approval for the Parish Manager to go out for 30-day bid on a new 750 Gallon Trailer Mounted Sewer Cleaner and identify the funding source. An extensive discussion was held comparing the cost of a new sewer cleaner in 2017 versus the cost of one today. The price has basically doubled. The jury authorized the Parish Manager to seek quotes for a new culvert cleaner, find a funding source and present back to the jury for future consideration. No further action was taken.
5. Chairman Leroy Blanchard requested authorization for the Special Programs Director and the Intake Coordinator to attend the ACAP Conference in Lafayette on February 9-11, 2026 at an estimated cost of \$1,400. A discussion was held with Committee Member Jamie Ponville relative to the General Fund budget and the spending of funds on trainings that are not 100% required. The Special Programs Director spoke of a portion of the training being mandatory but not in its entirety and the State just wanting them all present for the entire training. The Secretary-Treasurer stated that her portion of the required training is only 1 day. She will travel just for that day, not incurring lodging expenses. The jury requested that the Special Programs Director find out specifically what trainings are required and which are optional.
6. Committee member Chris Carter, offered a motion, seconded by Mr. Ron Alcorn, "THAT, the committee approve for the Special Programs Director and the Intake Coordinator to attend the ACAP Conference in Lafayette on February 9-11, 2026 at an estimated cost of \$1,400." This motion was unanimously adopted.
7. Chairman Leroy Blanchard requested authorization for the OHSEP Director and the Special Assistant to the Parish Manager to attend the 2026 Commercial Pesticide Applicator Recertification in Alexandria on January 21, 2026 at an estimated cost of \$500.
8. Committee member Chris Carter, offered a motion, seconded by Mr. Ron Alcorn, "THAT, the committee approve for the OHSEP Director and the Special Assistant to the Parish Manager to attend the 2026 Commercial Pesticide Applicator Recertification in Alexandria on January 21, 2026 at an estimated cost of \$500." This motion was unanimously adopted.
9. Chairman Leroy Blanchard requested a discussion relative to the 50 yr. Intergovernmental Agreement with St. Mary Levee District and neighboring parishes relative to the Bayou Chene Control Structure. The Chairman stated that more discussion needs to be had relative to this agreement because the RESTORE funds will only fund this agreement for 10 years. What happens after this time and the RESTORE funds are fully expended? Chairman Leroy Blanchard stated that he has pointed this out to St. Mary Parish and they are working on a revision. No action will be taken at this time and he will follow up with St. Mary Parish and report back to the jury.
10. Chairman Leroy Blanchard requested a discussion relative to the previous cut-back recommendations made by the Secretary-Treasurer. The Secretary-Treasurer referenced the hand out in their packet listing the previous cut-back recommendations made to the jury over the past few years in anticipation of a budget crisis. An extensive discussion was held relative to the list provided. Committee member Jamie Ponville requested that all jurors review the listing and bring back any recommendations to the full jury.
11. Committee member Ron Alcorn, offered a motion, seconded by Mr. Jeff Naquin, "THAT, there being no further business to come before the Finance Committee, the meeting be adjourned." This motion was unanimously adopted.



Engineering/Grants Committee Meeting
Of the

1. Committee members recorded as present were: Mr. Jeff Naquin, Mr. Leroy Blanchard, Mr. Myron Matherne, Mr. Michael Dias, Mr. Charles Breaux, Mr. Jamie Ponville
Other Police Jurors recorded as present were: Mr. Ron Alcorn, Mr. Chris Carter, Mr. Ira Patureau
2. Chairman Jeff Naquin recognized Mr. Dwayne Veillion with GIS Engineering for an update on the Jolimar Street Drainage Project and the Belle Rose Lane Drainage Project. Mr. Veillion stated that relative to the Jolimar Street Drainage Project they are currently working on the preliminary plan set. The ITR should be done in a couple of weeks then they are to proceed with the environmental. Mr. Veillion also stated that he will provide a list of landowners to the Parish Manager. Relative to the Belle Rose Lane Project, they are still waiting for direction from the parish. Mr. Veillion also spoke of the Fiscal Annual Plan relative to the Amelia Levee Project. Committee member Leroy Blanchard stated that Assumption Parish will be the Project Sponsor. The Secretary-Treasurer stressed the limited staff of the Parish Administration's office in taking on this role.
3. Chairman Jeff Naquin requested an update from Duplantis Design Group relative to the Gerald St. Levee Project and the Ring Levees in Pierre Part/Belle River. No one was present with an update.
4. Chairman Jeff Naquin requested an update from Infinity Engineering on the Parish-Wide Sewer Plant Improvements Project. Mr. Brian Lauritsen requested an update on the contract amendment request presented to the jury. Assistant District Attorney Calabro spoke about the information provided and the review process that still needed to be done. He requested the matter be tabled at this time to allow for more time due to the holidays.
5. Chairman Jeff Naquin requested an update from the Special Programs Director/Grants Coordinator. The Special Programs Director/Grants Coordinator stated that she was in contact with H & H Electrical relative to the lighting grant and they are still in the process of gathering information for the application.
6. Chairman Jeff Naquin requested an update from South Central Planning Development Commission (SCPDC). Mr. Pat Gordon, on behalf of Ms. Cassie Parker with South Central Planning Development Commission requested approval to adopt a resolution approving and authorizing the President to sign Supplemental Agreement No. 1 – DOTD State Project No. H.015860 (Belle Rose Sidewalks, LA 1 & LA 308) which would lower the match request.
7. Committee member Michael Dias, offered a motion, seconded by Mr. Charles Breaux, "THAT, the committee adopt a resolution approving and authorizing the President to sign Supplemental Agreement No. 1 – DOTD State Project No. H.015860 (Belle Rose Sidewalks, LA 1 & LA 308)." This motion was unanimously adopted.
8. Chairman Jeff Naquin requested an update from Mr. Pat Gordon with South Central Planning Development Commission relative to the establishment and presentation of the RESTORE Act Multi-Year plan. Mr. Gordon presented the draft RESTORE Act Multi-Year plan which consisted of the initial required payment to St. Mary Parish and dividing the remaining funds annually to fund the maintenance of the Bayou Chene project. Mr. Gordon stated that the plan must be adopted by the parish and then put out for publication and public comments for 45 days. Once approved by the funding agency, then the RESTORE funds should be ready to be spent.
9. Committee member Leroy Blanchard, offered a motion, seconded by Mr. Myron Matherne, "THAT, the committee approve and adopt the RESTORE Act Multi-Year plan and publish on the parish website accordingly for public comments for 45 days and then final submission for approval." This motion was unanimously adopted.
10. Chairman Jeff Naquin requested an update on the Ag Center Roof Project. Mr. Joseph Savoie stated that he met with the contractor on yesterday. He stated that a resolution is in place and they will be starting the duct work tomorrow. He estimates 3-4 days to complete.
11. Mrs. Margo Castro with the Ag Office questioned the jury relative to the completion date. She is in the process of trying to plan and organize Ag Day which is a parish-wide event. She needs to know if the facility will be ready. Mr. Joseph Savoie stated that the contract time is running out and the construction should be complete.
12. Chairman Jeff Naquin requested an update on the Health Unit Repairs. The Parish Manager stated that the roof is complete and they are now working with the contractor on required interior repairs.
13. Chairman Jeff Naquin requested an update on the Courthouse Renovations Project. The Parish Manager stated that the grant funding deadline is February 22, 2026. He advised that he sent an email today to the contractors to speed up the process. No further action was taken.

14. Chairman Jeff Naquin requested approval to accept the low and responsible bidder for the Grant Park Restroom & Pavillion Building project to be Sage Construction, LLC contingent upon concurrence from Facility Planning and Control. A lengthy discussion was held relative to Mr. Savoie's recommendation of Sage Construction, LLC with a Base Bid of \$369,221.39 with a concurrent change order accepting Alternative No. 1 deduct of \$6,082.26 for a post tension slab; deduct of bid item No. 2 of \$11,580.80 for a 24" PDW culvert and deduct of Bid item No. 3 of \$18,047.11 for back stop fencing – chain-link resulting in a reduced contract amount of \$333,511.22. All to be contingent upon concurrence with the State office of Facility Planning and Control. There was more discussion about cutting back the project and leaving more funds available for future maintenance of the facility. Police Juror Chris Carter stated that he already cut back and allocated \$50,000 for future maintenance of the facility.
15. Committee member Michael Dias, offered a motion, seconded by Mr. Myron Matherne, "THAT, the committee approve and accept the low and responsible bidder for the Grant Park Restroom & Pavillion Building project to be Sage Construction, LLC contingent upon concurrence from Facility Planning and Control in the amount of \$333,511.22." This motion was unanimously adopted.
16. Committee member Michael Dias, offered a motion, seconded by Mr. Charles Breaux, "THAT, there being no further business to come before the Engineering/Grants Committee, the meeting be adjourned." This motion was unanimously adopted.

3. The Police Jury President then opened the public hearing to any comments and/or questions from the public relative to the proposed adoption of Budgets for 2026.
4. After 3 calls, there were no comments and/or questions.
5. Committee member Michael Dias, offered a motion, seconded by Mr. Charles Breaux, "THAT, the public hearing be closed." This motion was unanimously adopted.

Regular Meeting

1. The regular meeting of the Assumption Parish Police Jury was called to order by Police Jury President Leroy Blanchard in the Assumption Parish Police Jury Chamber located at 4813 Highway 1, Napoleonville, Louisiana.
2. Police Jurors recorded as present were: Mr. Ron Alcorn, Ward 1; Mr. Jeff Naquin, Ward 2; Mr. Ira Patureau, Ward 3; Mr. Charles Breaux, Ward 4; Mr. Michael Dias, Ward 5; Mr. Chris Carter, Ward 6; Mr. Leroy Blanchard, Ward 7; Mr. Jamie Ponville, Ward 8; Mr. Myron Matherne, Ward 9.
3. President Leroy Blanchard led the prayer followed by the pledge of allegiance.
4. The Secretary-Treasurer opened nominations for Police Jury President for 2026.
5. President Leroy Blanchard asked for the floor prior to any recommendations and a vote. He proceeded to state that he has been President for 3 years and he is not interested in moving forward as Police Jury President for 2026. He stated that the position requires more than that of a part-time individual. The volume of meetings to attend and the commitment required exceeds that of a part-time juror. He feels that the employee structure is missing that of a full-time individual that should participate in all these meetings being held outside the parish and keep track of all the projects. He feels that the jury should consider a different form of government. He feels that the government structure as is does not properly work with the number of grants they are pursuing and the amount of time required. He suggested a Consolidated form of government with a Parish President moving forward or a true Parish Manager separate and apart from Public Works. He asked that the board consider this recommendation and be open to more discussions regarding this possibility moving forward. Mr. Myron Matherne thanked Mr. Blanchard for his commitment and contributions over the past 3 years.
6. Police Juror Leroy Blanchard nominated Mr. Jeff Naquin. Following three (3) calls, there were no other nominations.
7. Police Juror Leroy Blanchard, offered a motion, seconded by Mr. Jamie Ponville, "THAT, Police Juror Jeff Naquin be elected to serve as Police Jury President for 2026." The motion was unanimously adopted.
8. President-Elect Jeff Naquin thanked the Jury for their confidence in him.
9. President Jeff Naquin opened nominations for Police Jury Vice-President for 2026. Police Juror Myron Matherne nominated Police Juror Ron Alcorn for the Vice-President's position. Following three (3) calls, there were no other nominations.
10. Police Juror Myron Matherne, offered a motion, seconded by Mr. Chris Carter, "THAT, the Police Jury approve and elect Police Juror Ron Alcorn as the Police Jury Vice-President for 2026." The motion was unanimously adopted.
11. President Jeff Naquin requested acceptance of the List of Committees for 2026 or any requested modifications. Modifications were made to the list of committees to switch out the new Police Jury President and Juror Blanchard. A few minor changes were made on committees as requested.
12. Police Juror Leroy Blanchard, offered a motion, seconded by Mr. Jamie Ponville, "THAT, the committee approve and accept the List of Committees for 2026 in accordance with the revisions." The motion was unanimously adopted.
13. Police Juror Chris Carter, offered a motion, seconded by Mr. Ron Alcorn, "THAT, the Police Jury approve and accept the time of the Regular Police Jury meetings for 2026 to be the 2nd and 4th Wednesday of each month with minimal exceptions at 6:00 pm with moving the January 28th meeting to January 26th and a change of the last meeting in November and December due to the holidays." The motion was unanimously adopted.
14. Police Juror Jamie Ponville, offered a motion; seconded by Mr. Myron Matherne, "THAT, the Jury approve to accept any corrections and approval of minutes of the December 17, 2025 Regular Meeting." This motion was unanimously adopted.
15. President Jeff Naquin opened the meeting to the public for comments, questions or concerns regarding the items listed on the agenda. Following three (3) calls, no other public comments were received.
16. President Jeff Naquin recognized Mr. Brad Daigle as a Candidate for the State Representative, District 60 race to fill the vacancy of Mr. Chad Brown.

17. Mr. Brad Daigle, Candidate for the State Representative District 60 race addressed the jury. Mr. Daigle thanked for the jury for allowing him to address the jury. He introduced himself as a candidate to fill the position of Former Representative Chad Brown. He introduced his wife as Jill Chauvin Daigle and stated that have 2 children. He stated that his roots are here in Assumption Parish since the 1700s. He continued stating that he is a self-employed small business owner since 1991. He is an independent risk manager and employee benefit consultant. His business partner, Derrick Babcock is the Party Chairman of the Republican Party of Louisiana. They have been together since 2016. Currently he represents Iberville Parish on the Greater Baton Rouge Port Commission and this is his 3rd term representing District 17E Iberville and Assumption Parish on the Republican State Central Committee. He stated that this is his first run for public office. His focus is on his constituents and 90% of the issues that unite us as a people and not on the 10% that divides us. He stated that he will work for anyone and everyone, regardless of political party. That is his commitment to the jury. Mr. Daigle also stated that currently, the Republicans have an inherited advantage in the Legislature. He stated that he feels he has an advantage on the local, state and federal levels over his opponent. He has works on campaigns in the past and has numerous political connections that can assist him in getting the job done. In closing he stated that he is running to be a voice that listens, lowers insurance costs, improve education, reduce crime, lower taxes and demand transparency for every tax dollar. He stated that his campaign is not about politics but is about our families, our future and the place we proudly call home. He stated that not only will he fight for the people, he will deliver for you.
18. President Jeff Naquin recognized the Drainage Committee Chairman Jamie Ponville, who stated that the committee met and approved the carryover of the 2025 projects as provided to 2026; approved substantial completion of the Himalaya Canal Clearing Project; authorized CJ Savoie Engineering to re-advertise the Marais Drainage Improvements Project; approved a scope modification in the amount of \$13,457.50 for additional engineering fees to be funded from project #93133; and approved and authorized the President to sign the CEA with Charles Michael Franklin as recommended by the Parish Manager.
19. Police Juror Jamie Ponville, offered a motion, seconded by Mr. Charles Breaux, "THAT, the Jury approve the Drainage Committee report as presented." This motion was unanimously adopted.
20. President Jeff Naquin recognized the Personnel Committee Chairman Michael Dias, who stated that the committee met and recommended the following matters: approved the re-appointment of Kim M. 

R.S. 30:1144, which provides "any solar power generation facility with a footprint of seventy-five acres or more which is not located wholly within an industrial-zoned area or a Louisiana Economic Development certified site shall comply with the standards set forth in this Section"; and

WHEREAS, the Louisiana Legislature also enacted La. R.S. 30:1142(B) which provides "any parish that has adopted solar ordinances may by resolution opt out of the siting requirements of this Part. Upon submission of such resolution so passed to the Louisiana Department of Conservation and Energy, the siting standards of this Part shall not apply to that parish"; and

WHEREAS, the Assumption Parish Police Jury adopted comprehensive solar energy regulations on February 27, 2024, establishing stringent requirements for utility-scale solar power generation facilities within the parish; and

WHEREAS, Assumption Parish's solar regulations are comprehensive and restrictive, providing robust protection for property owners while allowing for responsible solar development; and

WHEREAS, the Assumption Parish Police Jury continues to demonstrate ongoing oversight of solar development through requested approvals, ensuring compliance with local standards and community interests; and

WHEREAS, maintaining local control over solar facility siting allows Assumption Parish to address the unique characteristics of the parish and the need to balance property rights, economic development opportunities and the welfare of parish residents and property owners;

NOW, THEREFORE, BE IT RESOLVED, by the Assumption Parish Police Jury, in regular and legal session convened that:

1. The foregoing "Whereas" clauses are hereby adopted as set forth in the preamble to this Resolution.
2. The Assumption Parish Police Jury hereby elects to opt out of the statewide solar siting requirements set forth in La. R.S. 30:1144, pursuant to the authority granted in La. R.S. 30:1142(B).
3. The solar siting standards contained in Part 3 of Chapter 12 of Title 30 of the Louisiana Revised Statutes shall not apply within Assumption Parish.

4. The Police Jury President or his designee is hereby authorized and directed to submit a certified copy of this Resolution to the Louisiana Department of Conservation and Energy.
5. This Resolution shall take effect immediately upon its adoption.
