EXECUTIVE ORDER

**BY ORDERS OF THE POLICE JURY PRESIDENT
OF ASSUMPTION PARISH, LOUISIANA**

WHEREAS, the Louisiana Health Emergencies Act, LA R.S. 29:760, et seq., confers upon the Governor, through the Governor's Office of Homeland Security & Emergency Preparedness to respond to a Public Health Emergency with assistance from Louisiana Department of Health Office of Public Health, to declare such emergency(ies) or disaster(s) and to preserve the health and lives of the people of the State of Louisiana; and

WHEREAS, the U.S. Center for Disease Control and Prevention ("CDC") is responding to an outbreak of a respiratory virus called "Coronavirus" (CORVID-19) throughout the United States; and

WHEREAS, the President of the Assumption Parish Police Jury, Jeff Naquin, in an effort to assist the State of Louisiana, hereby agrees to cooperate with the State of Louisiana's effort to respond to the CORVID-19 event; and


WHEREAS, the Governor's Office of Homeland Security and Emergency Preparedness, through consultation with the Secretary of the Louisiana Department of Health, shall coordinate all matters pertaining to the public health emergency response of the State. The Governor's Office of Homeland Security and Emergency Preparedness, through consultation with the Secretary of the Louisiana Department of Health, shall have primary jurisdiction, responsibility and authority for planning, coordinating public health emergency response between the state and local authorities, collaborating with relevant federal government authorities, elected officials of other states, private organizations or companies, coordinating recovery operations and mitigation initiatives subsequent to public health emergencies, as well organizing public information activities regarding public health emergency response operations – all in strict accordance with LA R.S. 29:766; and

WHEREAS, through the State of Louisiana's Executive Department Proclamation No. 25 JBE 2020 and Proclamation No. JBE 2020-27, the Governor of the State of Louisiana has ordered certain measures to be taken throughout the entire State of Louisiana; and

WHEREAS, the President of the United States, Donald J. Trump, has declared a Public Health Emergency and a National Emergency to help deal with the CORVID-19 outbreak within the United States; and

NOW THEREFORE, I - JEFF NAQUIN, Police Jury President for the Parish of Assumption in the State of Louisiana, hereby order the Assumption Parish Office of Homeland Security & Emergency Preparedness to assist with the State of Louisiana efforts in managing this emergency or disaster. The Assumption Parish Office of Homeland Security & Emergency Preparedness through the Director, John Boudreaux, shall have authority within the powers vested to him under a Public Health Emergency, and shall be the point of contact for Assumption Parish Police Jury.
